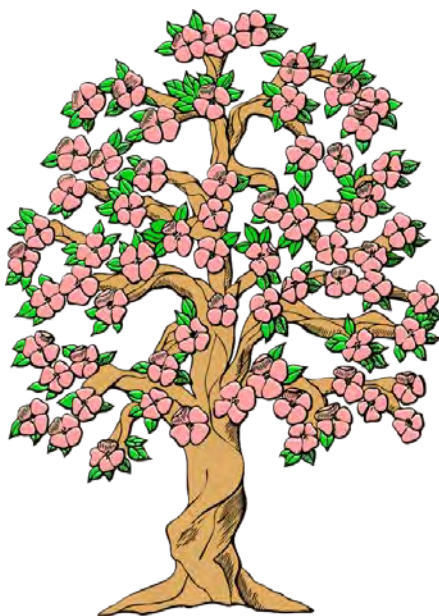


# Passenger Transportation Board Weekly Bulletin
