Revised Spreadsheets Enhance Taxi Data & Accessibility Info

The Board has modified its taxi data spreadsheets that most taxi companies use when they apply for additional vehicles. With the changes, taxi companies must report data for their wheelchair accessible taxis that is separate from data they report for their conventional taxis.
