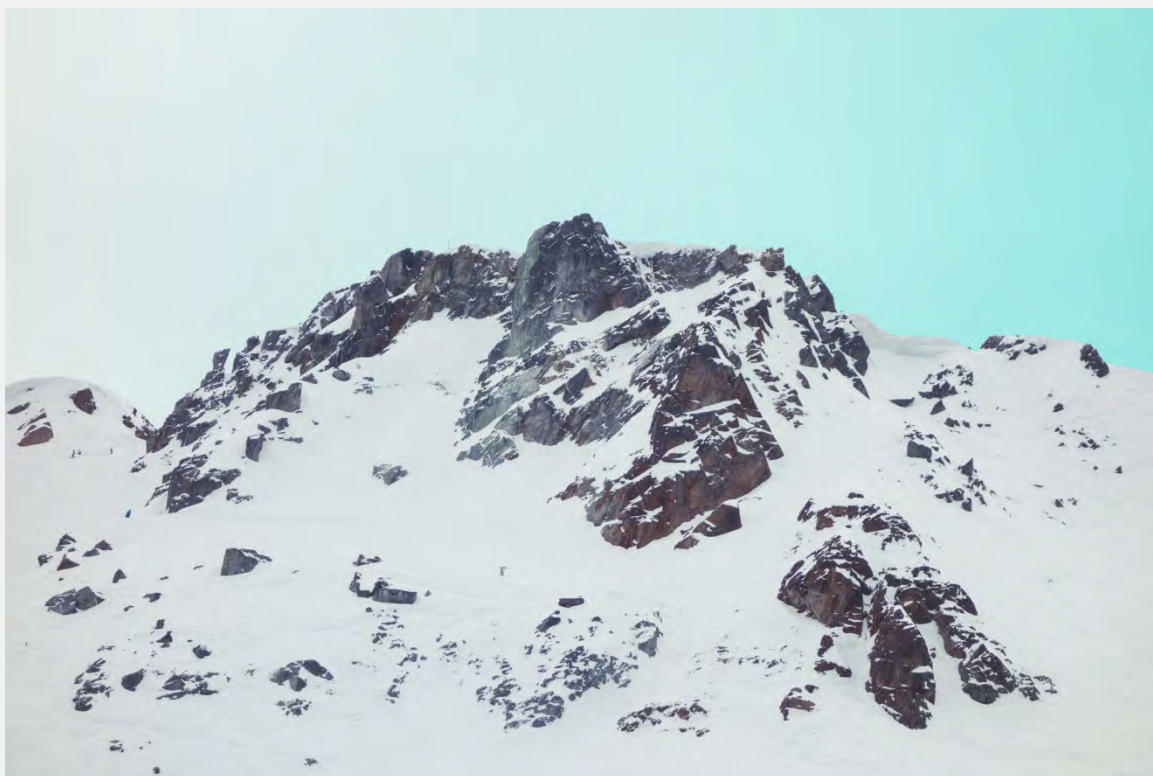

Festive Season TOPs for Taxis

For the 2018 ‘festive season’, taxi companies in BC may apply for Festive Season Temporary Operating Permits (FSTOPs) and choose any time period from November 15, 2018 up to and including January 15, 2019.

Peak Season TOPs for Limousine—Festive Season

Peak Season Temporary Operating Permits (PS TOPs) enables limousine operators to meet cyclical demands or season demands when additional vehicles are needed on a temporary urgent basis.

As needed, for the remainder of 2018, the Board may publish up to one extra edition of the Weekly Bulletin per week, either on a Friday or a Monday. This is in addition to editions that are published on Wednesdays. The extra editions respond to high volumes of applications and status enquiries about applications that have been received or decided by the Board. Most published applications and decisions relate to the Board’s streamlined process and policy respecting short term actions for taxi modernization, and its simplified Inter-City Bus Application process.
