New Single-Shift Paired Vehicle Application Form

The Board has approved a new single-shift paired vehicle (SSPV) application form to simplify the application process for interested applicants. See the Industry Advisory of June 11, 2020.

The Board has approved updated reference sheets, application guides and application forms to conform with 2019 amendments to the Passenger Transportation Act and Regulation.
