

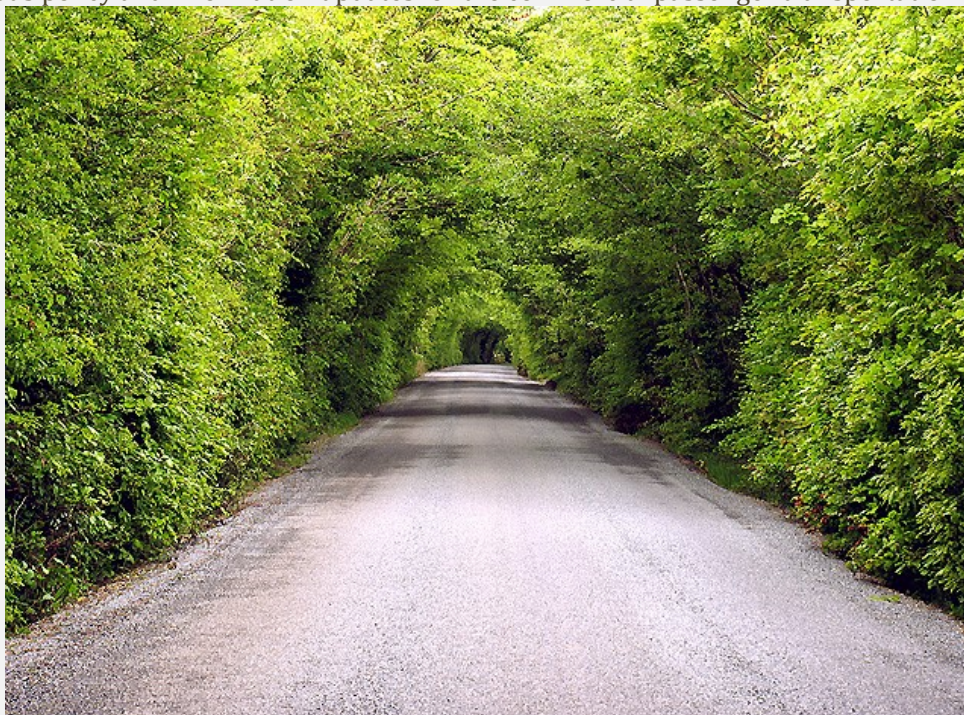

## **2020 TLCI**
